#### ❖ CLOSING DATES

Applications for first semester (February/March entry) are due by the end of October of the previous year, and for second semester (July entry) by the end of May of the year you are applying for. Before lodging an application for semester 2 please check with the relevant Admissions Office regarding the availability of mid year entry.

**LATE APPLICATIONS** - Entry to postgraduate coursework programs is very competitive. Late applications will only be accepted if places are still available, and the application can be processed in time for the start of semester.

#### DOCUMENTATION

You are required to supply with each application a certified copy of the full official transcript of your academic record in English for <u>all</u> tertiary study undertaken. This must show all courses attempted including failures, marks and/or grades and a statement that all requirements for the degree or diploma have been satisfied. (Please note a "course" is a subject, module or unit of study).

If you are currently enrolled in a program at another institution you should attach a certified copy of the official transcript of your results to date, and send results of your present program as soon as they are available. If a transcript is not yet available, you must attach a written record which includes grades in all courses. This information will be verified when your transcript is received.

If you have changed your name and your documents are in your former name, you must provide evidence of your name change.
