

UNSW Business School - Jindal Global Business School Master of Commece Articulation Pathway

Overview

Jindal Global Business School (JGBS) students who complete an integrated Bachelor of Business Administration + Master of Business Administration (IBM) or a two year Master of Business Administration (MBA) Degree have the opportunity to earn a further Master's degree at the UNSW Sydney Business School.

After successful completion of the JGBS program you may apply to enter the UNSW Master of Commerce program with advanced standing (credit transfers). Upon successful completion of the remaining courses at UNSW you are eligible to be awarded the degree of Master of Commerce.

UNSW Entry Requirements

 Successful completion of a JGBS BBA(Hons)+MBA or MBA program with a minimum credit average (65%) as determined by the UNSW Postgraduate Coursework Entry Score Calculator: www.admissions.unsw.edu.au/PGCalculators/index.php;.

Advanced Standing / Credit Transfer

Credit transfer is granted on assessment of modules studied in your JGBS program. A **maximum of 24 Units of Credit (UOC) / 4 courses** may be awarded towards the UNSW Master of Commerce depending on the chosen specialisation. Please refer to the advanced standing details below for more information on available credit. You will study remaining courses on campus at UNSW Business School, Kensington.

Notes

- 1. A standard UNSW Master of Commerce degree program is 72 UOC / 12 courses / 5 terms of full-time study.
- 2. UNSW is moving to a new academic calendar model from 2019. International students must enrol in 8 courses (48 units of credit) over the three standard terms (Terms 1, 2 and 3). This means that in one term, students can complete a lighter study load of 2 courses. It may be possible for students to complete 9 courses per year (3 courses per term) with permission from your Faculty. More information on UNSW 3+ is available online.
