# Universiti Kuala Lumpur (UniKL) Bachelor of Accounting (Hons)

If you are seeking to transfer from Universiti Kuala Lumpur after completing the 1<sup>st</sup> year of the Bachelor of Accounting (Hons) program, to the Bachelor of Commerce at the UNSW Australia Business School, you are eligible for advanced standing. Credit of up to 48 Units of Credit (UOC) or 8 courses (equivalent to 1 year) may be awarded. To receive the credit you will need to achieve a minimum CGPA of 2.8 out of 4.0. This CGPA will be assessed on a regular basis and may be subject to change.

### What you need to know

- Sponsored students may need to fulfil the sponsor's requirement of achieving a minimum CGPA of 3.0 out of 4.0 for transfer to the UNSW Bachelor of Commerce.
- Courses marked with \* are known as flexible core courses and the credit awarded for these courses
  may influence your choice of major/s for you to complete your study in 2 years.
- Courses marked with ^ will count towards the program as General Education. The number of General
  Education courses credited in the program may change depending on your choice of major/s, or if you
  decide to undertake a dual/double degree.

## **Professional Recognition for Accounting Students**
