Keynote speakers



Professor Sharon Hutchinson

Sharon Hutchinson is a Professor of Epidemiology and Population Health at Glasgow Caledonian University and Honorary Consultant with Public Health Scotland. Her epidemiological research (involving population-based surveys, data-linkage studies and statistical/economic models) focuses on the evaluation of interventions to prevent blood-borne viruses and related harms among people who inject drugs. Her work has guided Scotland's public health response to hepatitis C and HIV. In 2023, she was awarded the honour of Commander of the Order of the British Empire (CBE) for Services to Public Health Research.



Professor Steven Shoptaw

Steven Shoptaw PhD is Professor Emeritus and Vice Chair for Research in the Department of Family Medicine at UCLA. He co-directs the Big South/West Node of NIDA's Clinical Trials Network, where he leads randomised controlled trials on new medications for stimulant-use disorder. Dr Shoptaw jointly leads research, clinical and policy efforts to bring novel and high-impact strategies for persons affected by addictions and HIV. He works internationally with colleagues in Australia on medication development trials, and promotes testing and scaling up of addiction treatments in low- and middle-income countries.



Professor Michael Farrell

Professor Michael Farrell has been the Director of NDARC since 2011. Before that, he was Professor of Addiction Psychiatry at the Institute of Psychiatry at Kings College London. His extensive research interests include treatment evaluation and national and international drug policy, and he also has a long-standing interest in drug dependence, comorbidity and drugs in the wider criminal justice system. Professor Farrell is the Chair of the International Consortium on Health Outcome Monitoring Substance Use Working Group and Editor of the Cochrane Drug and Alcohol Group. He has been a member of the WHO Expert Committee on Drug and Alcohol Dependence since 1995.

Session chairs



Dr Norman Swan AM

Dr Norman Swan co-hosts RN's Health Report and the popular What's The Rash podcast. During the COVID-19 pandemic, he co-hosted Coronacast, which had monthly downloads in the millions. Dr Swan, a Gold Walkley award-winner, is also a reporter and commentator on the ABC's 7.30, Midday, News Breakfast and Four Corners. He created Invisible Enemies on pandemics and civilisation for the UK's Channel 4 and SBS, which was subsequently broadcast in 27 countries, and has authored three books, including bestsellers So You Think You Know What's Good For You? and So You Want To Live Younger Longer? Dr Swan has been awarded the medal of the Australian Academy of Science, an honorary MD from the University of Sydney, a Fellowship of the Australian Academy of Health and Medical Sciences, and the Medal of the Order of Australia (AM). He trained in medicine and paediatrics in Aberdeen, London and Sydney before joining the ABC.



Professor Nadine Ezard

Dr Nadine Ezard is an addiction medicine specialist and a founding fellow of the Australian Chapter of Addiction Medicine. She is a Professor and the inaugural Director of the National Centre for Clinical Research on Emerging Drugs (NCCRED) at UNSW. Also, since 2012, she has been the Clinical Director of the Alcohol and Drug Service at St Vincent's Hospital Sydney, which serves people with a variety of substance-use disorders in inpatient, outpatient and community settings and strives to embed innovation in practice. Previously, she worked for the World Health Organization, the United Nations High Commissioner for Refugees, and the United Nations Office of Drugs and Crime.



Daniel Madeddu

Daniel Madeddu PSM is the Executive Director of the Centre for Alcohol and Other Drugs at the NSW Ministry of Health. He has been working in Alcohol and Other Drugs policy since 2016. Prior to that, Daniel spent most of his adult life working in the HIV response across different settings such as the Ministry of Health, in Local Health Districts, for clinical epidemiology and social research organisations within the University of NSW, and in NGOs such as ACON and the Victorian AIDS Council/Gay Men's Health Centre.



Carmel Tebbutt

Carmel Tebbutt is the Chief Executive Officer of Odyssey House NSW, one of the state's leading alcohol and other drug (AOD) treatment and rehabilitation services. Prior to joining the not-for-profit sector, Carmel had a distinguished parliamentary career, holding senior ministerial portfolios including Health, Education and Community Services. She has made significant contributions to public policy, including serving as Co-Chair of the 2024 NSW Drug Summit, and brings extensive expertise across the mental health and AOD sectors. Carmel is deeply committed to reducing the harms caused by alcohol and other drugs, with a strong focus on early intervention, integrated service delivery, and reducing stigma for individuals, families and communities.



Professor Matthew Hickman

Professor Matthew Hickman is a Professor in Public Health and Epidemiology at Bristol Medical School, University of Bristol, at NDARC, UNSW and Glasgow Caledonian University. Professor Hickman is the co-director of the UK NIHR Health Protection Research Unit in Evaluation and Behavioural Science, with active research grants on the prevention of the hepatitis C virus, prevalence estimation and drug-related mortality.

Associate Professor Robert Ali AO

Associate Professor Ali is a public health physician and specialist in addiction medicine. Currently, he holds an emeritus Senior Research Fellow position at the University of Adelaide. Until October 2016, he was the clinical director of Drug & Alcohol Services South Australia; a role he held for 30 years. A/Prof Ali was a member of the Australian National Advisory Council on Alcohol and Drugs, has served on the WHO Expert Advisory Panel on Drug Dependence and Alcohol Problems, and was the Director of a World Health Organization Collaborating Centre based at the University of Adelaide. In 2023, he was awarded Officer of the Order of Australia for distinguished service to medical and health research, particularly drug and alcohol dependence, and to education and training.



Professor Mel Miller

Professor Mel Miller is Chair of NDARC's Advisory Board. She has been involved in the development of public policy in the health and human services sector for more than 40 years, in particular, that relates to alcohol and other drug-related harm and has led evaluations of the National effort on two occasions. She has both clinical and organisational psychology expertise and qualifications, a PhD in Social and Preventative Medicine and is now a Professor of Health, Social Policy, Economics and Evaluation in the Centre for Applied Health Economics at Griffith University and an Adjunct Professor of Psychology at the University of Queensland. Professor Miller has been a Member of the NDARC Advisory Board for over 15 years and became Chair in 2023.



Dr Mary Harrod

Mary Harrod is the CEO of the NSW Users and AIDS Association (NUAA), a peer-based organisation that delivers harm-reduction services across alcohol and other drugs and blood-borne viruses in New South Wales. Under her leadership, NUAA has expanded services, strengthened the peer workforce and pushed practical reforms that reduce stigma and improve access to care. Mary works with government, health services and community partners to champion lived and living experience partnerships as essential to safer health systems.



Associate Professor Michael Doyle

Associate Professor Michael Doyle is a Bardi man and leads First Nations health research at the Edith Collins Centre, Sydney Medical School, at The University of Sydney. He has worked in Aboriginal health since 1998. Michael is a mixed-methods researcher, and his PhD (completed in 2018) was the first by an Aboriginal person to focus on prison-based rehabilitation programs. He is currently leading the development of a new culturally informed social and emotional wellbeing program for Aboriginal and Torres Strait Islander people in prison.

Speakers



Dr Rachel Sutherland

Dr Rachel Sutherland is a Senior Research Fellow at NDARC, UNSW Sydney and currently holds an NHMRC Investigator Fellowship (2021-2025). Her research programme is focused on monitoring systems for detecting trends in illicit drug use, including new psychoactive substances, and developing and evaluating novel responses to emerging drugs of concern. Dr Sutherland is currently Deputy Program Lead for Drug Trends, and Program Lead of the Illicit Drug Reporting System (IDRS) and Ecstasy and Related Drugs Reporting System (EDRS).



Associate Professor Amy Peacock

Dr Amy Peacock is an Associate Professor and Deputy Director of the National Drug and Alcohol Research Centre (NDARC) at UNSW, and an Adjunct Researcher in the School of Medicine, University of Tasmania. She is a National Health and Medical Research Council Emerging Leadership Fellow. Dr Peacock is currently the Program Lead for Drug Trends, comprising the Illicit Drug Reporting System (IDRS), Ecstasy and Related Drugs Reporting System (EDRS), National Illicit Drug Indicators Program (NIDIP) and the Drug and New Technologies (DNeT) projects. She also coordinates the Australian Parental Supply of Alcohol Longitudinal Study.



Mia Miller

Mia Miller is a public health researcher with experience in alcohol and other drugs research. She has a background in working for the Australian Government Department of Health and the National Health and Medical Research Centre (NHMRC) in both cancer screening and infectious diseases policy. She is a mixed-methods researcher working on alcohol policy research at NDARC, with a focus on alcohol pricing and marketing, and no- and low-alcohol beverages (NoLos). She convenes the International Research Network on NoLos, which comprises more than 40 researchers across five continents.



Stassi Kypri

Stassi Kypri is a research assistant and doctoral student at the National Centre for Clinical Research on Emerging Drugs (NCCRED), UNSW Sydney. His doctoral research explores the collection and subsequent integration of community-based information into Australian drug monitoring and early warning systems.



Lily Palmer

Lily Palmer is a Research Officer with the Drug Trends Program at NDARC, UNSW Sydney, where she coordinates the NSW Ecstasy and Related Drugs Reporting System (EDRS) and the Illicit Drug Reporting System (IDRS). She previously worked as the Perth-based Research Officer on the Tina Trial, a national clinical trial of mirtazapine for methamphetamine dependence. Lily brings strong skills in participant engagement, team support and data management, and is passionate about harm reduction, reducing stigma and creating positive outcomes for people who use drugs.



Dr Nicola Man

Dr Nicola Man is currently a Research Fellow on the Drug Trends Program at NDARC, UNSW Sydney. She has an interest in the collection and statistical analysis of data from a variety of sources, including linked administrative data and household surveys. She was involved in a cross-jurisdiction data linkage project investigating the impact of the National Emergency Access Target (NEAT) policy on emergency departments in Australia. Dr Man has also collaborated on research projects involving hidden and marginalised populations vulnerable to HIV in low- and middle-income countries, health financing and equity in low- and middle-income countries and a prevalence study on parents with intellectual disability.



Dr Duong (Danielle) Tran

Dr Duong (Danielle)Tran is a medically trained epidemiologist and a Research Fellow at NDARC, UNSW Sydney. She has over 15 years' research experience in the utilisation of medicines, health services and health outcomes, leveraging 'big data' in real-world settings. Dr Tran leads multinational studies investigating the use and safety of prescription medicines for smoking cessation, mental health and substance-use dependence in pregnant people. She also conducted a study to assess how the Health Care Home primary care model affects the quality of care and patient outcomes for people in the community with chronic health conditions, the findings of which contributed to the reform of Australia's primary care. Dr Tran played a crucial role in developing the 'Join Us' research participant register, the first national research resource to engage Australian adults in health and medical research.



Professor Jonathan Brett

Professor Jonathan Brett is a senior staff specialist in clinical pharmacology, toxicology and addiction medicine at St Vincent's Hospital and a clinical toxicologist with the NSW Poisons Centre. He is a conjoint Associate Professor at St. Vincent's Clinical School and a Senior Research Fellow with the Medicines and Health Intelligence Unit at the School of Population Health, UNSW. His research areas span neuropsychopharmacology, drugs of abuse and medicines use in pregnancy, and he has expertise in large-scale observational studies using linked data, clinical trials of psychedelic assisted psychotherapy and clinical service evaluation.



Dr Krista Siefried

Dr Krista Siefried is Clinical Research Lead and Deputy Director of the National Centre for Clinical Research on Emerging Drugs (NCCRED) and Senior Lecturer at NDARC, UNSW Sydney, and St Vincent's Hospital Sydney Alcohol and Drug Service. She is a leader in clinical research and clinical trials in populations at risk of harms due to substance use disorders. Dr Siefried has extensive experience in clinical research, healthcare and clinical project management. Her broad clinical research interests include pharmacotherapies, comorbidities and treatment outcomes in people living with methamphetamine dependence.



Professor Rebecca McKetin

Professor Rebecca McKetin leads a research programme into stimulant use epidemiology and interventions at NDARC, UNSW Sydney. Her current research involves the online delivery of psychological help for people who use stimulants, the trialling of new pharmacotherapy options for methamphetamine dependence, and the development of novel responses to methamphetamine use in Aboriginal and Torres Strait Islander communities. Professor McKetin established the three-year-long Methamphetamine Treatment Outcomes Study of 501 methamphetamine-dependent individuals, demonstrating the impact of community-based treatments. She has also estimated the number of dependent methamphetamine users in Australia and contributed to regional drug monitoring systems in the Asia Pacific. Her work has quantified the risk of psychosis, violence and other mental health outcomes related to methamphetamine use. She holds the position of Senior Editor for Addiction, consults for the UN and is a Member of the Australian Institute of Policy and Science.



Dr David Goodman-Meza

Dr David Goodman-Meza is a Senior Research Associate at the Kirby Institute, UNSW Sydney. He is a clinician-scientist with expertise in infectious diseases and substance-use disorders. He has expertise in using methods from artificial intelligence to identify people who inject drugs and evaluate clinical outcomes in electronic health records, as well as experience in conducting clinical trials. Prior to moving to the Kirby, he was based in the United States and received several research grants from the US National Institute on Drug Abuse (NIDA).



Dr Brendan Clifford

Dr Brendan Clifford is a Senior Research Fellow with the National Centre for Clinical Research in Emerging Drugs (NCCRED), and a Clinician Researcher who uses interdisciplinary methods to further health equity and enhance access to evidence-based healthcare. He has a broad clinical background having worked in nursing in Ireland, the UK and Australia, mainly in emergency department settings. In addition to undertaking clinical research in alcohol and other drugs, he has also held roles in inclusive health innovation and lectured in public health and social science.



Dr Liam Acheson

Dr Liam Acheson is an early career researcher with the National Centre for Clinical Research on Emerging Drugs (NCCRED), with a focus on clinical trials of pharmacotherapies for the treatment of substance use disorders. Dr Acheson's current research program is broad, including clinical trials, the intersection of sleep and substance use, sexual health and qualitative investigation of client/participant experiences. Dr Acheson serves as the Deputy Chair of the St. Vincent's Hospital Sydney Human Research Ethics Committee.



Professor Donald Weatherburn

Professor Donald Weatherburn is a Professor at NDARC, UNSW Sydney and was formerly Executive Director of the NSW Bureau of Crime Statistics and Research. Prior to that appointment, Professor Weatherburn was foundation Research Director at the Judicial Commission of New South Wales. He has published on a wide range of topics including sentencing, criminal justice administration, crime prevention, drug law enforcement, harm reduction, and program evaluation. He has authored or co-authored 229 publications, including four books, over 100 peer-reviewed journal articles, nine book chapters, and 121 reports.



Dr Michala Kowalski

Dr Michala Kowalski is a Postdoctoral Fellow at NDARC, UNSW Sydney. She was awarded her PhD in 2025 for her mixed-methods study of alcohol policy in New South Wales, which examined the role of evidence in policy, the leading problematisations in alcohol policy, and analysed overlooked effects of alcohol policies in the state. Dr Kowalski's current research program concentrates on alcohol policy, cannabis policy, evolving drug markets and harm reduction. She is an active member of the Global Cannabis Cultivation Research Consortium and the Drug Policy Modelling Program Network, and co-convenor of the Safe(r) Supply Network in Australia.



Lucy Flood

Lucy Flood is a research nurse and clinical trial coordinator of the KAPPA Trial, an open-label safety and feasibility pilot trial of ketamine-assisted psychotherapy for methamphetamine use disorder. Lucy coordinates appointments, administers ketamine and monitors participants through both the GORMAN inpatient detox unit (OLAM) and the Stimulant Treatment Program at St Vincent's public hospital in Sydney.



Dr Thomas Santo Jr

Dr Thomas Santo Jr is a Postdoctoral Research Fellow at NDARC, UNSW Sydney, focusing on the epidemiology and treatment of drug dependence in prison and community settings. His research aims to reduce health and social harm related to drug dependence, particularly those in the criminal justice system, by supporting evidence-based policy and improving treatment access. Additionally, he plays a leading role in the Prison Outcomes Study (POST), which examines health and recidivism outcomes for formerly incarcerated individuals in NSW, and also leads the NSW Opioid Dependence Survey, which assesses and improves access to treatment and harm reduction services for people with opioid dependence.
