Terminology	Definition
Program compulsory core & flexible core courses	42UOC of compulsory and flexible core courses which students must complete under this degree.
Commerce Major	A sequence of approved courses (48UOC) in an approved discipline stream offered by the UNSW Business School (See Appendix A.), containing at least 18UOC at level 3. (Note that the 48UOC includes the first disciplinary course(s) in the Core (Compulsory or Flexible). This means that, for the majority of majors, students will complete 42UOC in specified disciplinary courses outside the core, except for the Real Estate Studies major.) For any majors that require ECON1202, MATH1011/MATH1031/MATH1131/MATH1141/MATH1151 completed under the Science component will act as a substitute so in these cases a student should not do ECON1202 but instead complete another Major elective to meet the 48UOC requirement.
UNSW Business School Elective	6-18UOC in UNSW Business School courses to ensure a student completes a minimum of 96UOC of Business courses within the Bachelor of Commerce. The exact number of courses to complete will depend on the major chosen. GEN courses cannot be counted as Business School electives.

If you have completed a Science course that excludes ECON1203, then you will need to study another 6UOC of UNSW Business School elective in order to meet the 96UOC from the Business School requirement.

* If student completes MATH1011, MATH1031, MATH1131, MATH1141 or MATH1151 under Advanced Science (Hons), then student cannot count ECON1202 under Commerce. If ECON1202 is required in the chosen Commerce major, then replace ECON1202 with another major elective.
