### Program and Course Terminology

Terminology	Definition
Integrated First Year Courses	Students must take 48 UOC of the integrated first year courses.
Commerce Major	Major Requirements: 48 UOC in an approved disciplinary stream containing at least 18 UOC at level 3. Note that the 48 UOC includes one course from the Integrated First Year. This means that students will complete 42 UOC in specified disciplinary courses outside the core.
Business School Electives	Students must take Business School Electives to complete a minimum 96UOC (16 courses) of courses within the Business School. Students are free to use these UOC to complete a second Commerce major or minor, however they need to be mindful of the program level 1 limit when making their selection. GEN courses cannot count as Business School Electives.
Free Electives <u>OR</u> Second Major OR Minor	Students can take up to a maximum of 36 UOC of the following courses. Students are free to use these UOC to complete courses from any Faculty or to complete a second Major or a Minor. However, they need to be mindful of the program limit on Level 1 courses (60 UOC) when making their selection. <u>NOTE: <i>GEN coded courses cannot count as a Free Elective</i></u> . Student undertaking certain double majors may not have any free electives.
Double Majors	Students completing a major sequence with courses in common which are not integrated 1st year course may only count the overlap towards one major and must replace this course within the other major with a major elective of the same level or higher.
General Education	Account for 12UOC (2 courses) and are to be taken outside the UNSW Business School. Please note: Students enrolled in programs within the UNSW Business School cannot take General Education courses offered by the UNSW Business School (i.e. GENC code). These restrictions also apply to the following courses: GENL2021 An Introduction to the Australian Legal System, and GENL2032 Cyberspace Law 2.0
myBCom	Students need to complete three non-credit bearing myBCom professional development elements including myBCom Blueprint (COMM0999), myBCom First Year Portfolio (COMM1999) and myBCom Graduation Portfolio (COMM3999)
Mandatory WIL course	Students must complete a 6 UOC Work Integrated Learning (WIL) course within their program. This course can count as a free elective or where applicable, can count as a Commerce major elective or Final Year Synthesis or General Education subject.
Final Year Synthesis	Students must complete either a 6 UOC Synthesis of Learning Course, or a 0 UOC Synthesis Experience. FYS would only be recognised if the course was completed within the remaining 48 UOC in the BCom program.
	Students who complete a Synthesis course that is also a Work Integrated Learning course within a major, will meet a major elective, WIL and Synthesis requirement.
Level 1 limit	The maximum level one limit in this degree is 60UOC (10 courses), excluding General Education courses.
Overall Program UOC	Students must complete a minimum 144 UOC (24 courses) across program requirements.
