The Animal Health Procurement Intern (Indirect) supports sourcing, supplier management, and purchasing activities for indirect categories (logistics, IT, marketing, logistics, professional services, vet devices, site services, R&D) supporting animal health. The role focuses on markets across ANZ, Asia, and Southern Africa, partnering with regional stakeholders to ensure timely, cost-effective, and compliant acquisition of goods and services that enable commercial, R&D, and operations teams. You will assist with data analysis, RFx processes, PR management, supplier onboarding, and spend optimization initiatives, while learning the unique regulatory and market dynamics of the animal health industry.

Key Responsibilities:

- Regional Indirect Sourcing and RFx Support
 - Help draft, distribute, and manage RFIs/RFPs/RFQs for indirect categories; consolidate supplier responses and support bid evaluations across ANZ, Asia, and Southern Africa.
 - Conduct market research and benchmarking on regional suppliers, pricing, lead times, and category trends relevant to animal health operations.
- Supplier Management
 - Assist with supplier due diligence and onboarding (including documentation relevant to animal health standards), and maintain accurate supplier records.
 - Track supplier performance against KPIs (on-time delivery, quality, cost, service levels) and prepare regional summary reports.
- Data and Reporting
 - Clean and analyze indirect spend data; support category dashboards and savings trackers.

- Compliance and Risk
 - Verify adherence to procurement policies, delegation of authority, and contract terms; support documentation aligned with animal health industry standards and regional regulations.
 - Support basic contract lifecycle tasks.
- Continuous Improvement
 - Identify opportunities to streamline processes, improve data quality, and standardize templates across regions.
 - Contribute to special projects (e.g., e-procurement tool rollout, supplier diversity, sustainability initiatives relevant to animal health supply chains).
