Summary of the Course

The course covers both the theory and practical applications of drilling fluids and well cementing technology. The main topics include: the functions, composition and additives of drilling fluids; clay and polymer chemistry and applications in drilling fluids; drilling fluid density determination and calculations; drilling fluid filtration and mud caking process; API drilling fluid properties, equipment and testing procedures; chemical analysis; drilling fluid system design for control formation damage and wellbore stability; drilling fluid hydraulics and cuttings transportation; cement manufacture, composition and standardization; cement additives; cement slurry rheology properties; API cementing testing equipment and procedures; cement slurry design and calculations; mud removal by cement; gas migration; cementing equipment and procedures; post-job considerations and evaluation; drilling fluids and cementing laboratory.

Course Aims

This course will enable students to acquire fundamental knowledge of drilling fluids, drilling hydraulics and cementing technique and to apply the theory to the design, evaluation and optimization of drilling fluid program, drilling hydraulics and cementing operations.
