



# Credit Transfer: International University - Vietnam National University Bachelor of Business Administration 2+2

Students who successfully complete the first two years of the IU Bachelor of Business Administration transfer program and apply to the **Bachelor of Commerce** at UNSW Business School, are eligible for up to **48 Units of Credit (UoC)/8 courses** of transfer credit.

To be eligible for transfer credit, students must achieve a minimum **CGPA of 70** out of 100 in the first two years at IU, and satisfy [English Language proficiency](#) requirements for admission to UNSW by providing an Academic IELTS test result with a minimum of 6.5 overall and no subtest below 6.0.

## Integrated First Year transfer credit

Students must successfully complete all IU courses listed below to receive the corresponding UNSW IFY transfer credit. This transfer credit is applicable from Term 1 (February) 2022 intake.

credit for ECON1101 Microeconomics and ECON1102 Macroeconomics and must enrol in [COMM1900 Organisations in Their Environment](#) for exemption of COMM1100 and COMM1150. COMM1900 will be counted as a BCom elective and may restrict the ability to complete a double major without extending your program duration and cost.

This is an exception for IU students commencing at UNSW in 2022 and 2023 only. Students commencing at UNSW in 2024 are expected to have completed BA167NS Introduction to Vietnamese Legal System or an equivalent.

## General Education credit^

The following courses may be counted towards a maximum credit transfer of 48 UOC / 8 courses and will count towards General Education program requirements only.

## myBCom

Students who receive a minimum of 24 UOC/4 courses of IFY transfer credit will also be awarded credit for COMM0999 myBCom Blueprint (0 UOC).

## myBCom Bootcamp

The BCom Bootcamp is held each intake to welcome transfer students to the Bachelor of Commerce. The Bootcamp is designed to connect you with other students, create a sense of belonging and be both challenging and fun.

The bootcamp provides you with the opportunity to meet the minimum Program Learning Outcomes standard as expected of students who have completed the Integrated First Year at UNSW Business School and contributes to [COMM1999 myBCom First Year Portfolio](#) in the [myBCom series](#), a core requirement of your program.

Attendance is **compulsory** for all transfer students. Delaying your attendance to BCom bootcamp may delay the completion of your degree.
