

UNSW Business School Articulation Pathway Transfer Credit: Bachelor of Economics, BINUS University

Students who complete the first two years of the BINUS University S1 Finance International Program, or S1 International Business program with a minimum CGPA of 2.8 out of 4 are eligible for transfer credit to the Bachelor of Commerce at UNSW Business School.

The transfer credit awarded to students may be a combination of Integrated First Year (IFY) courses and other courses approved for credit to a maximum of 8 courses/48 Units of Credit (UoC). A standard UNSW Business School course has a 6 UoC weighting. BINUS Students are required to satisfy English Language proficiency requirements for admission to UNSW.
