#### A PROCEDURAL MATTERS

### 1. Welcome, apologies and leave of absence

The Chair extended his respects to Elders past and present, and acknowledged the Traditional Custodians of all the lands from which members were joining the meeting.

The Chair welcomed everyone to the meeting, with particular reference to the following:

The Chair also thanked outgoing Chair of Arc, Mr Pike, and outgoing Indigenous Student Representative, Ms McKee, for their participation on the AB.

The Chair congratulated Professor Kable for his election as AB President and expressed full confidence in his leadership of the AB from July 2023 with the two elected Deputy Presidents (see item 7.1).

The AB accepted the apologies received from AB members for the meeting, as listed above.

#### 2. Minutes of the previous meeting held on 16 May 2023

#### **RESOLVED**

The Academic Board confirmed the minutes of its meeting held on 16 May 2023 as an accurate record, and authorised the Chair to sign them digitally, with the following minor amendment:

Professor Crossley reported that there was no update as UAQC had not met since the 27 June 2023 AB meeting. He would report back after UAQC consideration of the matter.

#### 4. Declarations of Conflicts of Interest

The Chair called for declarations of conflicts of interest with any matters before the AB. No declarations were provided.

5. Starring of items, adoption of unstarred items and rearrangement of the agenda
The AB received a request to star item 8 and carried a motion to adopt all the unstarred items.

# B PRESIDENT'S BUSINESS

# 7. Report of the AB President

The AB noted the June 2023 report of the AB President, which covered the Chair's time on the AB for more than 20 years and as President for 6.5 years. He congratulated the AB and its members for travelling well in their role on the peak academic body at UNSW.

# 7.1 2023 AB election results – AB President and two Deputy Presidents for a term from 1 July 2023 to 30 June 2025

The AB noted the election of Professor Kable as President of the Academic Board, and Professor Scott and Scientia Associate Professor Rollins as Deputy Presidents of the Academic Board for a term from 1 July 2023 to 30 June 2025.

7.2 Amendments to the UNSW Rules – approved by UNSW Council on 19 June 2023 The AB noted the updates to the UNSW Rules as approved by UNSW Council on 19 June 2023.

# 7.3 Appointment of Dr Diana Perche as Such other Person to AB – approved by UNSW Council on 19 June 2023

The AB noted that Council approved the appointment of Dr Perche to the AB under the Such other Persons (SoP) membership from 1 July 2023 to 30 June 2025 – in her capacity as Chair of the Program Review Committee (PRC).

## 8. Question on Notice (QoN)

Performance relative to opportunity adjustments and tenure, and promotions procedures

The AB noted the response to the QoN and that, before the pandemic, promotions committees at both Faculty and University levels considered and discussed broad HR matters, appointments, conversion and promotion for consistency, which remain important after the pandemic.

The Chair thanked Professor Annesley and the Chief HR Officer, Ms Amorelli, for the written response.

# 9. Report of the Vice-Chancellor (VC)

Acting Provost – Operations, Scientia Professor Williams, reported on behalf of the VC who apologised for not being able to attend the last meeting of the outgoing AB president.

➤ On behalf of the AB and the University, the VC wished to thank Professor Cohen for his significant leadership of the AB for almost 7 years (three terms) and his AB membership for 20 years, noting an uplift in student engagement on the Board among his numerous achievements. Professor Williams thanked Professor Cohen for his UNSW involvement for 33 years on the staff. Outside of the AB responsibilities, Professor Cohen is a notable academic and President of the Australian Geoscience Council, and will continue his connection with UNSW in an honorary capacity. Professor Williams noted that Professor Cohen's contribution and humour would be missed, and wished him well for the future.

#### **RESOLVED**

The Academic Board recorded a vote of thanks to Professor Cohen for serving as President of the Academic Board and for his distinguished service to, and exemplary leadership of, the Board, which was acknowledged by acclamation.

- Professor Williams welcomed Professor Maddison as DVCESE and thanked Professor Lutze-Mann for her role as Acting DVCESE in the last year.
- ➤ The AB noted the VC's recent disestablishment of the Management Board and the Senior Leadership Team, which would be replaced with the University Leadership Team (ULT) to meet fortnightly and the VC's Advisory Meeting (VCAM) to meet weekly (three times per month). The VC's intention with the changes in organisational structures is for ULT to be collaborative in making decisions and serve the University. VCAM will consider operational issues as they arise for advice to be provided by relevant University leaders. Professor Williams reported that the ULT planning day on 28 June 2023 would consider and discuss the new structures, the new strategic planning process, reforming systems across the University, and key strategic focus areas, including a deep dive into assessment reform and UNSW3+.
- Professor Williams reported on the following appointments:
  - DVC Global Colin Grant joined UNSW on 26 June 2023.

- PVC Industry & Innovation, Dr Stephen Rodda, would join UNSW on 8 August 2023.
- Recruitment of the Provost and DVC/PVC Indigenous should be completed in the coming weeks.
- The positions of Deputy Vice-Chancellor Equity, Diversity and Inclusion and Vice-President External Engagement will be consolidated into a newly created role of Deputy Vice-Chancellor or Vice-President Societal Impact, Engagement and Equity to focus on Societal Impact. The position of PVC Inclusion to be created will build on the important work progressing in the EDI space.
- Professor Williams thanked Associate Professor Bruce Watson for his work in the Equity, Diversity and Inclusion space, and Ms Fiona Docherty for the leadership she has demonstrated in External Engagement.

The Chair thanked Scientia Professor Williams for the update on behalf of the VC and for all the good wishes.

#### C PRESENTATIONS AND DISCUSSION TOPICS

# 10. UNSW College HEP (Higher Education Provider) Update and Student Transition Planning

The AB noted the paper on the UNSW College HEP Update.

Ms Lightfoot, the CEO of the newly registered and rebranded UNSW College (previously UNSW Global) and Mr West, the Executive Director, Academic presented on the following:

- Overview of transition from UNSW Global to UNSW College
- HEP progress to date
- TEQSA feedback supporting the outcome of the submission to become a HEP
- The UNSW College governance structure
- The TEQSA accredited HE programs and the UNSW degrees for which UNSW College will act as a feeder

The AB noted the following next steps for the UNSW College:

- Finalise CRICOS & FEE-HELP approvals
- Finalise transition plan
- Undertake transition consultation/approvals with UNSW
- Finalise transition planning with TEQSA

It was noted that sources within TEQSA considered the UNSW College application to be the best they had ever seen.

The Chair thanked Ms Lightfoot and Mr West for their presentation and update. He congratulated them on the seven-year registration of UNSW College in the category of Institute of Higher Education and the excellent progress made thus far. The AB agreed that a close relationship should be maintained between the UNSW AB and the Academic Board of the UNSW College.

#### D REPORTS

# 11. Deputy Vice-Chancellor, Research & Enterprise (DVCRE)

The AB noted the report of the DVCRE.

Professor Fisk summarised the following:

- The trip to China in May by UNSW colleagues, which included discussions about opportunities for the domestic and international UNSW student community, including industry placement, joint PhD programs, increased student mobility, and startup/entrepreneurial support
- The 21 new major grants secured by UNSW, worth \$52.4M
- The results of the 2023 Nature Index (NI) rankings released on 15 June 2023

- A national consultation by the Department of Health and Aged Care to improve alignment and coordination between the MRFF and the Medical Research Endowment Account (NHMRC funding)
- The annual URC/UHDRC Strategy Day held on 25 May 2023, which included discussions
  of the Trailblazer Universities Program and their proposed cultural change initiatives, the
  EF communities of practice and the establishment of a research translation community of
  practice, and methods for building a positive research & innovation culture at UNSW,
  noting that many of the suggestions to improve the research culture at UNSW would be
  implemented in the next 12 months

The AB noted that the best outcome yet for UNSW in the results of the 2024 QS World University Rankings would be delivered the next day, which would be reported on at the next AB meeting.

Professor Fisk paid homage to the outgoing AB President, who had met with him regularly over the years and engaged with the research bodies and the annual research planning day.

The Chair thanked Professor Fisk for his report, and congratulated him, his Division and the University, in advance, for the good news story about UNSW rankings expected to be released the next day.

# **12.** Deputy Vice-Chancellor, Education and Student Experience (DVCESE) AB noted the report of the DVCESE, Professor Maddison.

Professor Maddison thanked the Chair and the AB for their warm welcome, and highlighted the following in her report:

- The international student load is ahead of plan.
- The accommodation concierge service has commenced operations to assist students in obtaining off-campus accommodation.
- There is a great deal of activity in the student and staff community around generative
  artificial intelligence (AI) with much focus on the challenges that contract cheating and the
  misuse of generative AI present to the integrity of academic assessment, as well as
  constructive ways and opportunities to use AI in learning & teaching. Generative AI is
  having various impacts on UNSW, including a marked increase in the number of courses
  requesting in-person invigilated examinations in T3 2023.

Professor Maddison, assisted by outgoing acting DVCESE Professor Lutze-Mann, presented on the hot-off-the-press 2022 national results of the Quality Indicators for Learning & Teaching (QILT) SES (Student Experience Survey). The results show UNSW remains in the lowest quartile with Sydney, Melbourne and Monash for the overall undergraduate student experience, but has improved from 2021 and has shown the greatest overall improvement since 2019 (pre-COVID) for all universities. UNSW continues to perform strongly in the postgraduate space.

AB noted the following key insights:

- The sector is recovering from challenges to the student experience related to the COVID-19 pandemic, with overall improvements seen across quality indicators.
- UNSW's ranking has seen some improvement to 39 out of 42 in 2022.
- UNSW is one of only 7 universities that improved overall educational experience ratings between 2019 and 2022 by 7.1 percentage points, the largest improvement by far.
- Results are largely stable across quality indicators year on year, with marked improvements in Learner Engagement (46.3 in 2021, 57.4 in 2022) and Learning Resources (76.1 in 2021, 81.6 in 2022).
- The quality of undergraduate students' entire educational experience has improved from 66.9 in 2021 to 69.9 in 2022.

• UNSW remains above the average for postgraduate overall.

Professor Maddison thanked staff for their work in supporting excellent teaching and the student experience, and increasingly engaging with students outside the classroom.

In concluding the discussion on QILT, Professor Crossley emphasised that UNSW cares deeply about its students and the desire to continue improving and delivering a great student experience.

The AB noted that UNSW leads the GOS (Graduate Outcomes Survey) results – which is the ultimate test of the quality of the University's programs and graduates following their 3, 4 or 5 years of study at UNSW.

The Chair thanked Professors Maddison and Lutze-Mann for the presentation, to be circulated to the AB after the meeting.

# 12.1 Degrees awarded with distinction – 1 June 2022 to 31 May 2023

The AB noted the number of degrees awarded with distinction, from 1 June 2022 to 31 May 2023, including total number of degrees conferred, number 'at pass' and percentage of total 'at distinction'.

#### 13. Deputy Vice-Chancellor, Academic Quality (DVCAQ)

AB noted the report of the DVCAQ, Professor Crossley.

Professor Crossley reported that after the census date, the University's student load is stable as enrolment targets have been met for T1 2023, with international students just above target, and UNSW's student load is expected to be on target for T2 2023.

Regarding the ESOS (Education Services for Overseas Students) return to compliance, Professor Crossley reported on the following:

- Work with the International Student Compliance Team to monitor compliance with the reinstatement of ESOS requirements is ongoing.
- A small proportion of enrolled onshore students with international student visas are currently at risk of being non-compliant, due to scheduling issues in some cases (i.e. inperson classes are full or not offered for their chosen courses). Some of these students have not responded to UNSW emails and survey regarding their intention to continue their studies in Australia.
- Faculties are being contacted to ensure sufficient in-person classes are available in Term 3 to allow students to meet the requirements of their student visa.
- The office of the DVCAQ will liaise with TEQSA as required to ensure there are no adverse impacts on current students in Australia.
- About 590 students remain offshore and will have their CoE (confirmation of enrolment) cancelled in line with ESOS requirements. Students will have the chance to appeal, and if they return for T3 2023, they will be able to continue their studies onshore.

Professor Crossley agreed to provide a statement on ESOS requirements to help the Faculties to achieve compliance and facilitate consistency across the University while maintaining some flexibility through hybrid learning and teaching that is not detrimental to the mental health of students and staff [Matter Arising].

Professor Crossley thanked the AB President for his hard work as a member and leader of the Academic Board over many years while remaining true to himself in all his University collaborations.

The Chair thanked Professor Crossley for his report and ongoing engagement with TEQSA on academic matters impacting on the University community. On behalf of the AB, the Chair

congratulated Professor Crossley on his appointment as a Member of the Order of Australia (AM) in the recent 2023 King's birthday honours.

# 18. 2022 Student Conduct and Complaints Annual Report – Confidential: this version is not to be distributed outside of UNSW

The AB noted the findings of the 2022 Student Conduct and Complaints Annual Report, which would be released publicly on the UNSW website by the Conduct and Integrity Office (CIO), once reviewed by all relevant UNSW committees.

The AB discussed the following:

- Detection is not a reflection of all incidents of misconduct as there is underreporting of academic misconduct at UNSW, with only about 3% of the student headcount being reported.
- <u>Students</u> and <u>staff</u> can register a complaint about suspected student misconduct. Student complaints may be lodged anonymously.
- The CIO has developed a tool to detect and investigate contract cheating, reducing the time-consuming and manual task of uploading Moodle logs to IP look up providers from hours and days to minutes, which also analyses the IP locations used. This detail is not in the annual report as the tool is still undergoing tests, consultation, internal checks and approval from UNSW Cyber Security, privacy etc.

It was noted that as the reporting period, up to December 2022, overlapped only briefly with the rise of ChatGPT, reporting on the unauthorised use of generative artificial intelligence models as well as support for staff and students would be included in the next annual report.

The Chair thanked Ms Greene and the CIO for the detail and the high quality of the report.

# 19. Engineering Postgraduate Coursework Provisions (Information Technology, Engineering Science, Food Science and related proposals) – see AB agenda items 17.2 and 17.8.2

Professor Pagnucco presented on the summary of proposed updates and the coursework wireframe for the following three suites of Engineering postgraduate coursework programs and related academic offerings: 8543 Master of Information Technology, 8338 Master of Engineering Science and 8037 Master of Food Science.

The AB noted the following:

- The aim of the updates is to optimise the quality and speed of the University's assessment of recognition of prior learning (RPL) for advanced standing at the point of admissions.
- The proposed package of academic proposals is the result of a triangulation of marketsmart intelligence, administrative sustainability, and academic rigour and compliance.

Professors Foster and Pagnucco discussed that the changes would enable:

- significantly more principled and coherently structured programs based on alignment with the Australian Qualifications Framework (AQF),
- significantly reduced administrative burden for academic and professional staff,
- the availability of more streamlined and supportive programs for a broader range of future students while mitigating risks associated with the assessment and award of credit for advanced standing through RPL,
- faster application turnaround times resulting in improved Faculty planning and competitiveness for future student recruitment, and
- improved equity and access for students via alternative pathways into Engineering's inperson Master programs or transfers between programs so as not to disadvantage any student, thus assisting in improving the overall student experience.

The AB endorsed the proposed updates to the Engineering postgraduate coursework programs, in principle. The Faculty aimed to provide the academic proposals for consideration and approval by the AB at its meeting on 15 August 2023, according to the following implementation roadmap:
