The Chair acknowledged the excellent work of Professor Johnston AO at UNSW, especially as Dean of Science, and wished her well in her new role at the University of Sydney.

B PRESIDENT'S BUSINESS

7. Report of the AB President (Chair)

AB received and noted the Chair's report.

- 7.1 **Amendments to the UNSW Rules (ABPC ToR and vacancies in the Office of AB President/Deputy Presidents)**

RESOLVED

The Academic Board recommended to UNSW Council of 11 April 2022 that it approve the proposed amendments to the UNSW Rules.

Note for the record

AB discussed the following:

- Changes to the UNSW Rules to allow the Board to co-opt members to the role of acting Deputy Presidents if they have to take leave in excess of three months, and to fill casual vacancies.
- The term of the acting appointment may be unknown in some cases; hence the recommendation by Governance not to run elections.
- In the case of the President having to take leave, one of the Deputies would act in that role.

7.5 **Establishment of the Australian Graduate School of Engineering (AGSE), Faculty of Engineering**

AB noted the approval of the establishment of the Australian Graduate School of Engineering (AGSE) according to Section 7.3.1 of the Register of Delegations, which provides the approval of a committee comprising the Chancellor, Vice-Chancellor and Academic Board President, acting unanimously.

7.6 **Report on the Representation on UNSW Committees and Decision-making Bodies**

AB noted the 2021 annual report on the Composition of UNSW Committees and Decision-making Bodies.

In response to a question about Chairs of Committees/Boards co-opting members to help committees/boards to meet the gender balance requirements of the [Representation on UNSW Committees and Decision-Making Bodies Procedure](#), the Chair reminded the Board of the provisions for Chairs of Committees/Boards to make adjustments to the membership of the Committees/Boards through additional appointments. As some senior leaders were not necessarily aware of the *Procedure*, it would be referred to all formal committees/boards for noting and/or action.

8. **Question on Notice (QoN) – Work Integrated Learning (WIL)**

AB noted response from Professor Piggott (Director, Experience and WIL) to the WIL question from Ms Bhattacharya, the President of the UNSW Student Representative Council (SRC).

9. Report of the Vice-Chancellor (VC)

The Chair invited Professor Brungs to provide his first report to the Board as Vice-Chancellor of the University.

The VC thanked everyone for the warm welcome, noting that his first few weeks at UNSW had been exciting and positive. He noted that although he had already met many students and staff either virtually or in person in his first few weeks as Vice-Chancellor, he hoped to meet more staff and students in person as soon as possible while encouraging everyone to maintain COVID-safe practices and vigilance to keep everyone as safe as possible on campus.

The VC highlighted the following:

- Through the [Ideas Hub](#), he was listening to staff and students on what they considered important to them and the University. He hoped to bring some thoughts and observations on key academic matters to an AB meeting in the near future for further consideration.
- Students should send their ideas to him through the SRC and Arc student leadership.
- The dedication of UNSW colleagues and leadership in providing an exceptional student experience, especially in the student-centred approach to the learning and teaching challenges of the pandemic was impressive.
- The recent O-Week had been a huge success with the help of the student bodies and staff. The VC thanked everyone involved.
- UNSW had received the 2021 National Student Safety Survey (NSSS) report and took the findings very seriously. The report demonstrated the profound impacts of gendered violence on students. The University would soon finalise and circulate a new Gendered Violence Strategy 2022-2025.

The VC took on notice a request for more detail about the University's release of a set of principles that speak to maintaining UNSW salaries competitive in the sector. After the meeting, the Chief HR Officer provided the following response:

'As part of the Enterprise Bargaining (EB) process UNSW is seeking to provide staff with salary increases which are sustainable, equitable and ensure UNSW remains an institution with one of the most competitive salary rates in the sector. The EB process at UNSW has only just commenced and, for this reason, it is not possible to provide any further detail on the proposed salary rates at this stage. I would encourage you, however, to regularly visit the [EB page](#) on the HR Hub where we will provide regular updates and further information for staff as we progress through the EB process.'

The VC thanked everyone at UNSW who continued to demonstrate the University's commitment to having a positive impact, locally and on a global scale. He found it inspiring to see staff and students tackling challenges head on, using the expertise of the University community to develop real solutions, and pursuing the UNSW vision of improving lives around the world affected by devastating local and international events.

The Chair thanked the VC for his report, noting that the Board would devote a substantial part of an AB meeting in the near future to consider and address key academic matters identified by the VC.

C PRESENTATIONS AND DISCUSSION TOPICS

10. Research Commercialisation Update

Professor Fisk and Mr Dawson (Director of Knowledge Exchange) presented on the Research Commercialisation slides included in the meeting papers and the implications for future research funding streams as well as HDR support related to university-industry partnerships and collaborations.

AB noted that the Commonwealth Government recognised that commercialisation of Australian research is well short of its international research performance. The Trailblazer Universities Program had been launched with UNSW as the lead for *Recycling and Clean Energy* and main partner for *Concept to Sovereign Capability*.

The Chair thanked Professor Fisk and Mr Dawson for their update.

11. Arts, Design & Architecture (ADA) Program Portfolio Overview

Associate Professor Watson (Deputy Dean, ADA) presented with Ms Sutton on the design process of the major revisions to the undergraduate (UG) degree portfolio in the Faculty of Arts, Design and Architecture (ADA).

AB noted the following:

- The ADA program portfolio overview would result in a significant reduction in the number of UG programs and a simplification of degree rules and structures without the loss of specialisations (disciplines/majors) while designing new suites of courses, where necessary.
- The changes would assist in the development of simpler degree planners for students and staff, and the simpler marketing of programs to prospective students.
- ADA's Project Governance timeline aimed to present the new and revised ADA program proposals to AB in June 2022 for approval and inclusion in the ADA offerings from 2023.

On behalf of the Board, the Chair congratulated Associate Professor Watson and Ms Sutton as well as their teams for the Faculty's excellent work in achieving this program simplification, which would benefit not only the Faculty but also the entire University. He thanked them for their insightful presentation and wished them well in completing the project.

D REPORTS

12. Deputy Vice-Chancellor, Academic & Student Life (DVCASL)

The Academic Board received and noted the report of the Deputy Vice-Chancellor, Academic & Student Life (DVCASL).

Professor Crossley congratulated and thanked Associate Professor Watson and Ms Sutton for their excellent work and presentation on the ADA program portfolio overview.

Professor Crossley's summary of his report included that the University's total student load was essentially ahead of target despite about 50% of international students continuing to study remotely, and he thanked staff and students for managing hybrid learning and teaching to the best of their ability.

Regarding setting a deadline for students to return to campus for face-to-face classes and/or giving them sufficient notice of an expected return to campus, Professor Crossley advised that the University continued to highlight the advantages of students returning to campus as soon as possible but would avoid setting a deadline that could disadvantage overseas students who were not yet able to return to campus. The University would continue to review the decisions in this regard to benefit both staff and students.

Regarding the overall status of the Inspira Digital Assessment Project being red due to scope and resourcing markers, Professor Steel explained that the essentials of the program were on track and that the budget was expected to be approved during the March Stage Gate check.

The Chair thanked Professor Crossley for his report.

12.1 **Student Experience Update**

In the absence of Professor Wilkinson, Professor Crossley provided a student experience update in which he highlighted the following:

- The University enjoyed an upward trend in all key teaching quality and student experience indicators, for which Professor Crossley congratulated and thanked staff on behalf of the University.
- UNSW continued to maintain high entry standards (median ATAR of 92) with among the best retention rates and the best graduate outcomes among undergraduates and postgraduates in the sector.
- The key areas for improvement remained assessment and feedback, teaching and student engagement as well as the pace of the Trimesters.

The Chair thanked Professor Crossley for the update.

12.2 **Indigenous Alternative Entry Scheme for postgraduate programs & refining the process for allocating Commonwealth Supported Places (CSPs) to postgraduate students**

The AB endorsed:

1. Refining the process for allocating Commonwealth Supported Places (CSPs) to postgraduate students; and
2. the proposed Indigenous Alternative Entry Scheme for postgraduate programs in the School of Population Health in the Faculty of Medicine & Health as well as the Juris Doctor Program in the Faculty of Law & Justice.

12.3 **Report from the University Librarian**

The AB noted the report from the University Librarian, which focused on Library engagement with students and teaching academics in 2021, and summarised the service improvements planned for 2022.

13. **Deputy Vice-Chancellor, Research & Enterprise (DVCRE)**

The Academic Board received and noted the report of the Deputy Vice-Chancellor, Research & Enterprise (DVCRE).

14. **Academic Promotions Policy and Academic Promotions Procedure Updates**

The Chair reported that although he believed the UNSW promotions processes were good, fairly transparent, simple and fair, and that the relevant committees went out of their way to find grounds to promote staff and take into account factors outside the control of the applicants, procedures can always be improved to enhance the processes. Professor Crossley discussed the upcoming review of the *Academic Promotions Policy* and related *Procedure*, including a suggestion to include the term 'collegiality' in the broad areas under which applicants were assessed, which AB members generally supported. AB noted that the review of this Policy and Procedure would include University-wide consultation.

The Chair thanked Professor Crossley for the update.

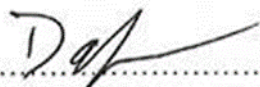
