UNSW Law and Justice's PLT Program, the Graduate Diploma in Legal Professional Practice (GDLPP) has two intakes per year. Students have the option to commence in February (Term 1, T1) or September (Term 3, T3). Coursework is undertaken consecutively (except during electives where students undertake two 3UOC elective courses concurrently). This course structure has been designed to accommodate students undertaking full or part time work, caring responsibilities or other study.
