### 1. What is the research study about?

For the first time, the 2026 Census will ask all people aged 16 and over about their gender and sexual orientation. There are many uncertainties about how people will respond. The questions are new, some people may not complete the Census themselves, and others may not feel safe or comfortable sharing this information.

We want to understand:

- How LGBTQ+ people plan to answer the Census questions.
- How parents, caregivers, or other adults who live with and care for LGBTQ+ people plan to answer.
- Whether the Census questions align with how people describe their gender or sexuality.
- How factors like privacy and household relationships could affect Census responses.

This is important because Census data informs how governments direct funding, services, and policy decisions. Understanding how people are likely to respond will help ensure LGBTQ+ people and households are properly counted and represented.

### 3. Inclusion Criteria

To take part in this study, you must:

- Be aged 16 years or older.
- Be currently living in Australia.

And you must also meet at least one of the following:

- Identify as lesbian, gay, bisexual, queer, or another diverse sexual orientation.
- Identify as transgender, non-binary, or another diverse gender.
- Be a parent, caregiver, or other adult who lives with and cares for an LGBTQ+ person.

- Have had sex in the past 12 months with someone of the same gender, or with a trans or non-binary person.

### 4. Do I have to take part in this research study?

Participation in any research study is voluntary. If you do not want to take part, you do not have to.

If you decide you want to take part in the research study, you will be asked to:

- Read the information carefully. If you have any questions, you can contact the research team at [LGBTQResearch@unsw.edu.au](mailto:LGBTQResearch@unsw.edu.au).
- Complete the online questionnaire.

### 5. What does participation in this research require, and are there any risks involved?

If you decide to take part in the study, you will complete a 10 to 15 minute online questionnaire. It will include:

- Questions about you, such as your age, gender, sexual orientation, and other background details. This helps us understand who is taking part and how different people might respond to the Census.
- Either how you plan to answer the gender and sexual orientation questions in the upcoming Census or how you think someone else would report your details if answering on your behalf. This helps us understand how people interpret the questions and how proxy reporting might affect data accuracy.
- Your attitudes and opinions about the Census questions, including whether they feel accurate or reflect how you actually identify. This helps us assess whether the questions are meaningful and inclusive.

Data from the online questionnaire will be collected and securely stored through the REDCap Survey Platform hosted at UNSW Sydney. Some people may find the topics sensitive or feel emotional distress when reflecting on their gender, sexuality, or experiences. If this happens, stop the survey at any time by closing your browser, and access free support services listed below. ### 6. What are the possible benefits to participation?

There are no direct benefits to you from taking part in this study. However, your responses may help improve how data about LGBTQ+ people is understood and used. Census data informs how governments make decisions about funding, services, and policies. This study will support more accurate interpretation of the 2026 Census by exploring how LGBTQ+ people and households are likely to respond. It may also contribute to more inclusive and respectful data practices in future research and policy settings.

### 7. What will happen to information about me?

This is an anonymous survey. We will not collect your name, contact details, or any other identifying information in your survey responses. Your data will be stored in a non-identifiable format, and your identity will remain unknown.

Your deidentified survey responses may also be stored and used in future ethically approved research on LGBTQ+ population health, census methods, or related public health topics. Any future use will involve de identified data only and will occur under appropriate ethics or governance approvals. We will not release raw data publicly.

All data will be stored securely for at least seven years after the study is completed.

### 8. How and when will I find out what the results of the research study are?

The research team intend to publish the results of the research. All Information will be published in a way that will not identify you. If you would like to receive the results, you can provide your email address at the end of the survey. This will be stored separately from your survey responses and used only to send you the results.

### 9. What if I want to withdraw from the research study?

If you choose to take part, you can stop at any time by closing the questionnaire. However, because the survey is anonymous, your responses cannot be withdrawn once submitted.

The information you provide is personal information for the purposes of the Privacy and Personal Information Protection Act 1998 (NSW). You have the right of access to personal information held about you by the University, the right to request correction and amendment of it, and the right to make a complaint about a breach of the Information Protection Principles as contained in the PPIP Act.
