About the Centre

The Centre for Social Research in Health (CSRH) is a specialist research centre based in UNSW Arts and Social Sciences. Our mission is to undertake and promote exemplary social and behavioural science research in health that informs and strengthens knowledge, policy and practice.

Our research is guided by our commitment to:

- Integrity and excellence in academic research
- A multidisciplinary approach to research and education
- Actively ensuring our unique and critical perspectives are heard
- Collaboration and engagement with affected communities, and
- Valuing diversity and promoting equity.

Since its establishment in 1990 as the National Centre in HIV Social Research, the scope of our research program has evolved to influence and respond to a broad range of national and international health strategies and priorities, with the ultimate aim of improving the health and wellbeing of affected individuals and communities.

Our researchers are leaders in their fields, with a strong reputation in the academic community, lending authority to our work and influence to public debate. We are committed to contributing to effective policy and practice by working in partnership with community, government and research partners.

The Centre fosters the talents of the next generation of social science researchers through support for early career researchers and our postgraduate research program.

We receive funding from a range of sources, including the Australian Government Department of Health, state and territory government departments/ministries of health, competitive funding bodies, partner organisations and international sources.

Director's Report

2014 was yet another big year for CSRH with the Centre continuing to thrive. While all the achievements of our staff and students are documented throughout this report, there are some in particular that I would like to briefly highlight.

A standout achievement is that CSRH staff produced yet another record number of publications, exceeding the marked increase we saw in 2013. We initiated several exciting new projects in 2014, including an EU-funded people exchange program on narrative health communication, in partnership with universities in The Netherlands, Belgium, Germany and Western Australia. A UNSW consortium of CSRH and the Kirby Institute was awarded the NSW BBV&STI Research, Intervention and Strategic Evaluation (BRISE) program, a 5-year comprehensive research, knowledge exchange and capacity building program tendered by NSW Health.

We also organised the highly successful 13th Social Research Conference on HIV, Viral Hepatitis and Related Diseases, which was perhaps the most exciting in the series I attended. Building on a session at this conference and our long history in community engagement, we ran a symposium on HIV criminalisation, stigma and discrimination for World AIDS Day, involving academic, community and legal perspectives. CSRH also had a strong presence at AIDS 2014, through both our contributions to the conference organisation and our presentations. Unfortunately the proceedings of this first in the series of International AIDS Conferences to be held in Australia were overshadowed by the loss of our friends and colleagues on board flight MH15. We remember them all with affection.

After nearly 15 years with the centre, the wonderful Janice Knapman retired from the Centre to focus on life's other priorities. We also said goodbye to Judi Rainbow and wish her all the best. We welcomed Mandy Schippers who joined us as e-Research Developer. I am also very pleased that several esteemed colleagues joined the centre as visiting or adjunct fellows and we welcomed Gary Dowsett (Adjunct Professor), Denton Callander (Adjunct Lecturer), Grenville Rose (Adjunct Lecturer) and Zong Yu (Visiting Fellow). I congratulate Peter Aggleton with his appointments as UNSW Scientia Professor, Visiting Professorial Fellow at the UCL Institute of Education, and Adjunct Professor in the Australian Research Centre in Sex, Health and Society. Congratulations also go to Martin Holt for his Endeavour Executive Fellowship awarded by the Australian Government Department of Education and Training.

The research team behind the Gay Community Periodic Surveys (Martin Holt, John de Wit, Peter Hull, Toby Lea, Evelyn Lee, and Limin Mao) must also be congratulated as recipients of the 2014 UNSW Arts and Social Sciences Dean's Research Award for Social Impact, alongside Dean Murphy who was awarded the Dean's Research Award for Most Publishable Manuscript by an Early Career Researcher or Higher Degree Completer. I congratulate Joanne Bryant and Christy Newman who were appointed Joint Editors of Health Sociology Review, and Philippe Adam who was appointed Associate Editor of Frontiers in HIV and AIDS. Congratulations also go to Denton Callander, Maude Frances, Hannah Wilson and Dean Murphy who all completed their postgraduate research degrees at CSRH.

My sincere thanks go to all at CSRH, our collaborators and our funders for making 2014 such a successful year.

Performance Targets and Achievements

Our work is guided by the CSRH Strategic Plan 2012-2015. This responds to the Australian Government's five national strategies for blood-borne viruses and sexually transmissible infections (National BBV & STI Strategies 2014-2017), and supports the UNSW Strategic Intent (Blueprint to Beyond) and priorities of UNSW Arts & Social Sciences.

CSRH performance targets encompass outcomes related to supporting and promoting research; education, including learning, teaching and students' experience; external engagement; and capabilities and resources. CSRH achievements against agreed key performance targets for 2014 are outlined in the following table.

Key Performance Targets	Achievements
Bolster research project funding	In the current climate of fiscal restraint, CSRH has been very successful in obtaining research funding that is on par with previous years. In addition to renewed and continued funding from established funders we have also obtained funding from new sources. We also successfully navigated the NSW Health transition from research grants to research tenders.
Sustain strong publication profile	The number of publications produced by CSRH staff included in the Higher education Research Collection has further increased, from the marked rise in 2013; for these publications we preferentially target esteem journals and publishers. We also launched a social media presence in 2014 to coincide with our bi-ennial conference.
Intensify impact on policy and practice	CSRH research continues to be at the forefront of the policy and practice agenda. CSRH publications are widely cited in policy documents, CSRH staff participate in many policy committees and regularly present at critical policy and practice forums. In 2014 CSRH staff significantly increased their contribution to workforce capacity building in NSW and internationally.
Extend collaborations within FASS	In 2014 CSRH staff collaborated on more tenders and research grant applications than before with colleagues at the Social Policy Research Centre. CSRH and SPRC also jointly and successfully applied for funding from the UNSW Major Research Equipment and Infrastructure Initiative. CSRH staff convened and contributed to courses of the School of Social Sciences, developed a new joint course with the School of Education, and initiated development of a joint course with the School of Social Sciences.
Increase international partnerships	In CSRH staff continued and extended visiting appointments at international universities. CSRH staff also developed research grant applications with partners in the region, North America and Europe. CSRH staff initiated new collaborations in Southeast Asia with international partners.

In 2015, CSRH operations will continue to be guided by the following priority key performance objectives:

- Bolster research project funding
- Sustain strong publication profile
- Intensify impact on policy and practice
- Extend collaborations within UNSW Arts & Social Sciences
- Increase international partnerships.

Research

Our research is organised into five key areas:

HIV, sexual health risk and risk reduction

Viral hepatitis, injecting drug use and harm reduction

Living with, and treatment of, serious and chronic conditions

Sexuality, health and education

Health promotion development and evaluation

We focus our research on key population groups, including gay men and other men who have sex with men, people from culturally and linguistically diverse backgrounds, people in serodiscordant relationships, and sexually active young people.

We investigate a wide range of issues regarding hepatitis C risk and prevention, illicit drug injecting, and risk and harm reduction, including in intimate relationships.

Our research encompasses studies of the impact and lived experience of various health-related conditions on those directly affected as well as their carers and their communities.

We explore the diversity of expression of sexuality and sexual identities, issues of gender in relation to sexuality, the health and wellbeing of sexual and gender diverse individuals and communities, and sex and sexuality education.

Our work is concerned with the development and evaluation of innovative interventions that improve prevention, diagnosis, treatment and responses to care needs across health domains.

Postgraduate Research Program

CSRH offers a postgraduate program that provides students with the skills needed to undertake high quality research, contribute to academic and policy debates, and inform best practice. We offer expert supervision, from a diversity of social and behavioural science perspectives, for postgraduate research into the social and behavioural aspects of HIV, sexual health, sexual practices, viral hepatitis and drug use and related areas of education, health and wellbeing. Our students are passionate, engaged and motivated to understand and influence change in the fields of health, sex, drugs and risk.

The postgraduate research degrees offered are Doctor of Philosophy (PhD), Master of Arts by Research (MA) and a Graduate Diploma (GradDip). Our program has links with other programs in the Faculty of Arts and Social Sciences, in particular the School of Social Sciences, and in the Faculty of Medicine, notably the School of Public Health and Community Medicine and The Kirby Institute.
