

Sexual Misconduct

The enclosed data is from 1 July 2016 to 30 June 2020 and is an update to a previously released report (2011-2016). The latest report contains 75 alleged sexual misconduct incidents reported to the University for formal investigation between 1 July 2016 to 30 June 2020.

In 2017 UNSW established a range of support mechanisms to assist with the reporting of, and response to Sexual Misconduct. This included a new <u>Sexual Misconduct Reporting Portal</u>, a standalone <u>Sexual Misconduct Prevention and Response Policy</u>, a <u>RESPECT Survey</u> and a <u>First Responders Network</u>.

The <u>Sexual Misconduct Portal</u> launched (July 2017) with the objective of <u>making it easier for UNSW students or staff to report incidents</u> and find and navigate information on available support services resulting in an increase in the number of cases reported compared to the previous reporting period.

The Portal is a stand-alone reporting portal and data collection point for reports of sexual misconduct. It allows anyone to report an incident of sexual assault or harassment, whether they have been directly affected, are a witness to an incident or a support person. Reports can be made anonymously, or with full details provided, depending on the wishes of the reporter. Reports may also be made for past or off-campus incidents. Not all reports of sexual misconduct made to UNSW can be investigated - there are a range of reasons for this including, where the reporter does not want the matter investigated or where the respondent is not known, or not connected to the University. Even where the matter cannot be investigated all reports made through the Portal are responded to and information on appropriate support services provided.

In June 2017 an independent expert was engaged to review all existing policies and procedures in relation to sexual assault and sexual harassment, and to develop a Sexual Misconduct Policy. There was significant consultation on the development of the Policy, including with students, academic and professional staff, accommodation providers, unions, counselling, medical and professional staff. The UNSW <u>Sexual Misconduct Prevention and Response Policy</u> was implemented in June 2018 and updated in October 2018.

UNSW engaged Hudson Global Resources to undertake the <u>UNSW Respect! Survey</u> in April 2019 in response to the <u>2017 Australian Human Rights Commission report into Sexual misconduct & Harassment at Australian Universities.</u>

<u>UNSW First Responders</u> are volunteer students and staff who are trained by the Gendered Violence Research Network to provide support to those affected. There are 52 trained and accredited First Responders across all campuses.

Indecent Assault	Sexual assault that does not include rape	
Sexual Assault	illegal sexual contact that usually involves force upon a person without consent or is inflicted upon a person who is incapable of giving consent (as because of age or physical or mental incapacity) or who places the assailant (such as a doctor) in a position of trust or authority	
Sexual Harassment	Sexual harassment is an unwelcome sexual advance, unwelcome request for sexual favours or other unwelcome conduct of a sexual nature which makes a person feel offended, humiliated and/or intimidated, where a reasonable person would anticipate that reaction in the circumstances.
