Administrative history note:	<p>The Board of Studies in Taxation was established by Council on 5th November, 1990 (resolution CL90/95biii). At the initial meeting of the Board of Studies on 21st December, 1990, it was determined that the Board would be responsible for "the development of courses in the Australian Taxation Studies (ATAX) Program, the supervision of teaching and the conduct of examinations and the formulation of policy on such allied matters as qualifications for admission and requirements for student progression". The first Presiding Member of the Board was Professor Y. F. R. Gribch.</p> <p>On 25th August, 1997, Council approved a change in status of the Board and it therefore became a Board within the Faculty of Law (resolution CL 97/66b), therefore reporting through the Faculty to the Academic Board. As a result the Board was no longer serviced by the Secretariat and it was no longer necessary to have a Registrar's Nominee present.</p> <p>On 15 May 2006 Council approved the replacement of the Board of Studies in Taxation with the Australian School of Taxation (resolution CL06/36/6).</p> <p>On 7 September 2010 the Academic Board recommended that "the Chancellor, Vice-Chancellor, and President of the Academic Board approve the disestablishment of the Australian School of Taxation and the School of Business Law and Taxation, and, as a concomitant action, approve the establishment of the Australian School of Taxation and Business law within the Australian School of Business, effective 1 January 2011" (resolution AB10/101). This was approved on 20 September 2010 (file 2002/2060).</p> <p>The Australian School of Taxation thus ceased to exist from 1 January 2011.</p>
