Course Details & Outcomes

Course Description

Consistent with PSYC7212, this course provides theoretical knowledge and practical skills in

child and adult clinical psychology for candidates undertaking postgraduate training in clinical psychology. The focus is on aetiology, assessment, diagnosis, case conceptualisation, and empirically-supported treatment of clinical disorders across the lifespan. These problems will be considered within the individual client's relevant sociocultural context, with consideration given to providing culturally-responsive approaches to clinical care and collaboration with other professionals if indicated. The course is guided by a scientist-practitioner approach and covers best practice guidelines, with particular emphasis on consideration of our professional obligation to conduct safe and ethical practice and to protect the public while delivering evidence-based clinical services. The teaching activities include lectures, interactive activities (e.g., group discussions, role-plays), and self-guided online modules. Individual lecturers may assign readings that should be completed prior to the lecture.

Course Aims

The course aims to provide candidates with advanced knowledge about major theoretical frameworks for various forms of psychopathology across the lifespan and practical skills for intervening with clinical populations. This course will introduce candidates to assessment, diagnosis, and intervention approaches for several psychological disorders of childhood and adulthood, as guided by a scientist-practitioner approach. Demonstrations of assessment and therapeutic procedures and an opportunity to practice these skills will be provided in the practical sessions, with a particular emphasis on providing candidates with opportunities to practice implementing safe practice guidelines with clinical populations.

Assessment Details

Assessment Tool Presentation

You will be required to complete a 10-minute presentation on a single assessment tool/measure for assessing a specific childhood emotional or behavioural problem, such as: Child Behavior Checklist (CBCL), Conners, Multidimensional Anxiety Scale for Children (MASC), Children's Depression Inventory (CDI), Spence Children's Anxiety Scale, Inventory of Callous-Unemotional Traits (ICU), and Eyberg Child Behavior Inventory (ECBI) / Sutter-Eyberg Student Behavior Inventory (SESBI-R). You are expected to complete this task using materials from the UNSW Psychology Test Library and peer-reviewed literature. You must first gain approval on your selected tool/measure from the Course Convenor via email correspondence.

You will be provided with guidelines for the assessment in Week 1. You will give your presentation in Week 4. Your presentation must be no longer than 10 minutes in length and should be accompanied by slides. Following your presentation, you will be required to facilitate a 5-minute practical exercise involving administration and scoring practice. You will be required to contribute to a measures database in an online spreadsheet that details key features of the assessment tool (e.g., construct designed to be measured, age range, reporter, number of items, time to complete, psychometric properties, etc.). You will be assessed on your ability to apply advanced psychological knowledge to common psychological disorders and culturally-responsive assessment in clinical psychology. This assessment will be marked as satisfactory/unsatisfactory. Written feedback will be provided within 10 working days.

All assessments use competency-based standards. You must receive satisfactory on all assessment items to pass the course.

Podcast

You will work in pairs to create an educational and entertaining podcast episode on a specific psychological disorder or symptom presentation that occurs at any time across the lifespan. Your podcast episode should be targeted at a lay public audience. You are expected to complete this task using peer-reviewed literature. You must first gain approval on your selected topic from the Course Convenor via email correspondence. You are encouraged to be as creative as possible and to be inspired by existing popular podcasts.

You will be provided with guidelines for the assignment in Week 1. You will submit your podcast in Week 8. Your podcast episode should be no longer than 10 minutes and should be in MP3 format. You will be required to submit a written transcript of your podcast episode. You should email your recording to the Course Convenor via your preferred file transfer procedure, labelled in the following format: PSYC7204_SURNAME 1, SURNAME 2_zID 1, zID 2. You should submit the podcast transcript via Turnitin. Your Turnitin submission will act as your submission receipt. You will be assessed on your ability to apply advanced psychological knowledge to common psychological disorders and culturally-responsive assessment and treatment in clinical psychology. This assessment will be marked as satisfactory/unsatisfactory. Written feedback will be provided within 10 working days.

Written Final Examination

The final examination is designed to assess your learning on all topics across the term, including material from lectures and readings. The exam is typically 2 hours plus 10 minutes reading time and consists of several Short Answer responses and 1 Long Answer response. Details will be confirmed during the course. The examination will occur during the official University examination period (time TBA). You will be assessed on your ability to apply advanced psychological knowledge to common psychological disorders and culturally-responsive assessment and treatment in clinical psychology. This assessment will be marked as satisfactory/unsatisfactory. Your grade will be released during the University release of examination results period.

Penalty for Late Submissions
